To be valid this form of proxy, together with the power of attorney or other authority (if any) under which the same is signed or a notarially certified copy of such power of attorney or authority, must be lodged with the Company's Branch Share Registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, situated at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong by 10:30 a.m. on 31 May 2017 (Hong Kong time) (being not less than 48 hours before the time appointed for holding the meeting (or any adjournment thereof)).

In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the vote(s) of the other joint holder(s) and for this purpose seniority will be determined by the order in which the names stand in the Register of Members of the Company in respect of the relevant joint holding.
- 8. The proxy need not be a member of the Company but must attend the meeting in person to represent you.
